	Audit Firm — Chairman Sylvanus asked Ms. Kijak how she felt with the current firm and if they should seek RFP's. Ms. Kijak commented that the audit firm currently used Lauterbach & Amen are a very reputable firm. Continuing on that the GASB standards that are implemented have continued to make municipal audits more of challenge, noting that a lot of firms have stopped doing municipalities because of these standards. Committee Member Valentin noted that many have dropped down to only doing school districts.
