TOPIC	DISCUSSION	NEXT STEPS
<b>Minutes</b>	Committee Member Comstock moved to approve May 15, 2025 minutes. Committee Member Markunas seconded the motion. All Committee Members present voted aye. Motion carried.	
<b>Old Business</b>	<p>Committee was provided stats from JBPD, Staff reported tracker provided from statistical data of the three (3) amended Municipal Chapters; Burning, NonHighway and Boat Launch. Additionally, the discussion of the enforcement and tracking of the No Left turn on Chapel Hill Rd and Fairview Ave</p> <p>Committee Member Bierman expressed the lack in enforcement of Villages ordinances with CSO removed from duties. Significant decline on noting violations and follow-up being performed due to position vacant.</p> <p>Container Storage (Zoning 7.1-9) regarding EDC proposal of containers for a starting vision of incubator program. Committee discussed alternate location verse proposed Rescue Squad Park. Discussion was further explained reasoning for containers verse stick built on-site and the overall concept was well received among the ORD committee.</p>	<p>Staff to continue providing tracker of enforcement related to following for ORD committee review. Recommend no warnings being an option, discretion from officers, but citation to be issued</p> <p>Staff explained duties have been divided temporarily between P.D. and Staff with planning in place to ensure timely action, follow-ups and position replacement.</p> <p>Staff to ensure to provided ORD Committee recommendation to EDC the location of Sunnyside Memorial Park for the improvements and future activity to take place due to planned improvements projected. In summary, a more suitable location for incubator growth and accessibility.</p>
<b>New Business</b>	Amending Ch. 15.15 Operation of Non-Highway Vehicles on Village Streets (B) Permitted Streets. Committee reviewed the proposed amendment with supplemental information. Concerns were discussed among the committee after dialoged with the Chief of Police presentation and concerns raised. Committee discussed the original intent of NHV, which was the connection of community via golf carts, but the activity has increased community wide and some modifications has elevated to issues/complaints. Discussed alternatives for possibly ensuring connection within the community. In summary, the committee was not able to render a decision and wish to further discuss and alternatives to amendment language.	Chief of Police Greenwald attended said meeting providing his concerns with traffic data counts of approx. 10000 vehicles on said identified area, other motor vehicles utilizing the road, statistic finding of results related to incidents, potential outcome and effect allowing said proposed usage of Johnsburg Rd. Provided a presentation regarding the findings and the demand it could overall cause the P.D. and Village liability. Matter was tabled for further discussion.
<b>Chairman Report</b>	Chairman Morris provided updates from recent Village Board activities. Assigned activities to committee member to bring ordinances that need attention or further elaboration/clarification.
