ORDINANCE NO. 2024-25-01

An Ordinance Amending Chapter 15, Traffic, by adding and amending Section 15.15(C)(1), (7) and (8), of the Johnsburg Municipal Code

BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: Chapter 15, Traffic, of the Johnsburg Municipal Code shall be amended to add Section 15.15(C)(7), which shall read as follows:

15.15 OPERATION OF NON-HIGHWAY VEHICLES ON VILLAGE STREETS

- C. <u>Operation Regulations</u>: Where authorized, the operation of a non-highway vehicle is subject to the following:
 - 1. A non-highway vehicle shall be subject to inspection by the Police Department or Village designee prior to being operated on any of the permitted streets or designated paths. A fee of \$75.00 (vanity) and/or \$60.00 (automatic numerical issue) shall be assessed for the initial application/inspection of each non-highway vehicle followed by an annual reinspection renewal fee of \$25.00 for the same vehicle each year thereafter. Additionally, a registration plate transfer fee of \$25.00 for purchased non-highway vehicles that have already been inspected by the Police Department or Village designee prior. All fees will be retroactive to the date of permitted non-highway vehicle.
 - 2. A non-highway vehicle may only be operated on streets where the posted speed limit is 35 miles per hour or less.
 - 3. A non-highway vehicle may cross a designated street at an intersection where the street has a posted speed limit of more than 35 miles per hour.
 - 4. A person may not operate a non-highway vehicle upon any street in the Village unless he or she has a valid driver's license issued in his or her name by the Secretary of State or by a foreign jurisdiction.
 - 5. The operator shall yield the right of way to all pedestrian and vehicular traffic which constitutes a hazard.
 - 6. The operation of the non-highway vehicle shall be in compliance with the provisions of the Illinois Vehicle Code (Act 5, Chapter 625 of the Illinois Compiled Statutes, as amended).

- A person may not operate a non-highway vehicle upon any street or 7. designated path in the Village with a trailer or rear loaded apparatus attached for the purpose of carrying passengers. Exemptions may apply for Village authorized events such as parades when traffic control is being provided.
- All occupants must be seated in a non-straddle seat consistent with the manufacture's specification. Any modifications must insure that the manufacture's load capacity is not exceed.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
