ORDINANCE NO. 2024-25-30

An Ordinance Amending Chapter 8, Parks and Playgrounds, Section 8.03(F) Use of Park
Areas of the Johnsburg Municipal Code

BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: Chapter 8, Parks and Playgrounds, of the Johnsburg Municipal Code shall be amended to amend Section 8.03 (F)(2) & (3) as follows:

- F. Use of Park Shelters. The Village provides park shelters located in Sunnyside Memorial Park, Hiller Park and Rescue Squad Memorial Park which may be rented for private functions subject to the following provisions:
 - 2. A \$100 refundable deposit is submitted to the Village a minimum of 14 days prior to the date of event. Said deposit will be refunded within 14 days from the date of event upon an inspection by Village personnel to confirm that no damage occurred to the park and all trash and litter was picked up and placed in refuse receptacles provided at the park.
 - 3. A \$25.00 fee for residents and \$100 fee for non-residents shall be charged for rental of the shelter and must be paid a minimum of 14 days prior to the event.
 - 2. A refundable deposit of \$100.00 for residents residing in the corporate limits of Johnsburg and a \$200.00 refundable deposit for non-residents being submitted to the Village a minimum of 14 days prior to the date of event. Said deposit will be refunded within 14 days from the date of event upon an inspection by Village personnel to confirm that no damage, destruction or extensive cleaning and repairs occurred to the park and all trash and litter was picked up and placed in refuse receptacles provided at the park.
 - 3. A fee of \$50.00 for residents residing in the corporate limits of Johnsburg and a \$250.00 fee for non-residents shall be charged for rental of the shelter which must be paid a minimum of 14 days prior to the event. Four (4) picnic tables will be provided for park shelter rentals when available and not allocated to other Village functions or special events. Additional picnic tables may be provided for a fee of \$10.00 for each additional picnic table, when available, not to exceed six additional tables. Requests for additional picnic tables must be submitted to the Village a minimum of 14 days prior to the date of event.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
