

## ORDINANCE NO. 2025-26-28

### *An Ordinance Amending Chapter 15, Traffic, by amending Section 15.15(B) of the Johnsburg Municipal Code*

BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: Chapter 15, Traffic, of the Johnsburg Municipal Code shall be amended to Section 15.15(B), which shall read as follows:

#### **15.15 OPERATION OF NON-HIGHWAY VEHICLES ON VILLAGE STREETS**

~~B. Permitted Streets: Subject to the provisions of this Section 15.15, the operation of nonhighway vehicles shall be permitted on all the streets where the posted speed limit is 35 mph or less, as well as designated routes (collectively the "Permitted Routes") authorized by the Village within the Village's corporate boundaries which are under the jurisdiction of the Village with the exception of Johnsburg Road, Ringwood Road, Riverside Drive or any road under the jurisdiction of McHenry County.~~

B. Permitted Streets: Subject to the provisions of this Section 15.15, the operation of non-highway vehicles shall be permitted on all the streets where the posted speed limit is 35 mph or less, as well as designated routes (collectively the "Permitted Routes") authorized by the Village within the Village's corporate boundaries which are under the jurisdiction of the Village with the following exceptions: Ringwood Road; Riverside Drive; and Johnsburg Road, except that portion of, Johnsburg Road identified in 15.15(B)(1), Permitted Route. Non-highway vehicles are prohibited on any road under the jurisdiction of McHenry County.

1. **Permitted Route:** Low-Speed Vehicle (LSV) and Utility Terrain Vehicles (UTVs) shall be permitted on Johnsburg Road between where Johnsburg Road intersects with Fairview Avenue continuing north to where Johnsburg Road intersects with West May Avenue. Such LSV and UTVs, shall, be identified by a 17-character Vehicle Identification Number (VIN), capable of maintaining posted speed limit with flow of traffic, and must otherwise meet all safety standards as set by Village.
2. No golf cart (as defined 625 ILCS 5/1-123.9) would be permitted on Johnsburg Road due to the manufacture limitations of golf carts.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall take effect 10 days following its passage and publication in book form under the authority of the Village President and Board of Trustees, as provided by law.
