PRESIDENT'S REPORT

NEW BUSINESS – FIRST READ/NO ACTION

ORDINANCE 25-26-07 GROCERY TAX - Trustee Sylvanus reported on the Finance Committee's recommendation to reinstated the Grocery Tax. He stated that he spoke with a Walmart representative who reported that the store experienced \$22,000,000 in sales for food and perishable items last year and added that the Village also receives tax revenues for those items from other businesses such as Angelos and gas stations. Trustee Sylvanus reported that the Village would experience an estimated loss of \$405,963 in revenues annualy if the grocery tax is not reinstated. Trustee Hagen questioned what additional revenues would be experienced. It was explained that no additional revenues would be received, the ordinance, if approved, would just reinstate the grocery tax that is being eliminated beginning January 1, 2026 by the State. It was agreed that making up for the loss in revenues would be difficult and reinstating the tax will keep taxes consistent with current levels.

ORDINANCE 25-26-08 AMENDING AND RENAMING CHAPTER 41.... OF THE JOHNSBURG MUNICIPAL CODE - Vllage Administrator Sofiakis explained that the ordinance merges all of the tax related chapters in the Municipal Code into one chapter and, if approved, would add the grocery tax to Chapter 41 as well.

Both ordinances will be included on the Omnibus Agenda for action at the next meeting.

ADJOURNMENT – Trustee Fouke moved to adjourn the meeting. Trustee Sylvanus seconded the motion. All Trustees voted aye on the roll. Motion carried 7:13p.m.
