### PRESIDENT'S LETTER

am excited to report that representatives of Walmart Super Center recently came before the Village Planning and Zoning Commission and the Village Board with their proposed project. The Center will be located on the west side of Route 31 across from the J.C. Penney and The Shops at Fox River development. The project includes the Walmart Super Center, two outlots on Route 31 and an additional outlot at the far west property line. Open space will be included in the development along with wetland and stormwater enhancements. The Planning and Zoning Commission unanimously recommended the approval of the development. At the beginning of August, the Village Board reviewed the proposal and will consider action on it in the near future. We will keep you informed of this proposal's progress in future newsletters and on our website at www.johnsburg.org

Since our last newsletter, the Village has been working with Fairview Avenue residents who have expressed an interest in moving forward with wastewater treatment in their neighborhood. As I have stated many times in the past, our efforts are intently focused on finding alternative solutions to provide an affordable wastewater collection system to our residents in need. I believe that the Village's wastewater treatment improvement project is important to the overall health of our residents, the environmental health of the Fox River, our community and all those who use this precious resource for recreation and depend on it for drinking water. I hope our Village will be able to accommodate the request of those residents interested in moving forward and I will keep you updated as this project comes closer to becoming a reality.

To this note, I would like to clarify some misinformation that has circulated as a result of recent articles in the Northwest Herald regarding the pursuit of a stimulus loan for our wastewater treatment collection system. There is a misconception that stimulus funding is "free money". Stimulus funding for wastewater projects being disbursed through the Illinois Environmental Projection Agency's (IEPA) State Revolving Loan Fund (SRF), does not come in the form of a grant - it is a loan that must be repaid. The Village was initially informed of the possibility of stimulus funding in the fall of 2008. At that time, the Village submitted a list of projects through the Metropolitan Mayors Caucus. In February of 2009, the American Recovery and Reinvestment Act (ARRA) was signed into law. In March, the Village received notification that stimulus funding through ARRA would be disbursed through the IEPA's State Revolving Loan Fund. On March 10, 2009 the Village submitted an application to the IEPA's SRF for a \$10,000,000 loan for the west side sewer collection system. The Village then continued to work on the loan and communicated with the IEPA regarding their specific requirements. By the end of March, the Village was advised that pending litigation would have an impact on its ability to receive the ARRA loan through the SRF. Without

SSA #23 in place, a defined revenue stream was not available to secure the loan. The only revenue stream the Village could propose without the SSA was through a direct bill system, which would increase the costs to our paying residents to cover any loss of revenues resulting from individuals defaulting on their payments. The uncertainty of costs to our residents, along with potential litigation issues related to the pursuit of direct billing, impacted our ability to propose a direct billing system for the project.

Throughout April, the Village continued to pursue the loan through the SRF and determined that an estimated expenditure in the amount of \$10,000 would be needed to complete a planning report, the next step in the SRF process. The Village was informed by Representative Jack Franks that there was a large demand for SRF financing so municipalities should move quickly through the SRF application steps if they want to receive a loan. We continued our communications with the IEPA regarding the loan requirements and was informed via email "any project for which a planning report is not already in house has virtually no chance of receiving stimulus funding". The IEPA's email also stated "We do not want anyone to waste time, effort, or money if the only reason they were pursuing a project was in hopes of receiving stimulus money." A follow up telephone conversation with the IEPA confirmed that more than \$3.2 billion in requests were received and only \$170 million was available in stimulus financing through the SRF for sewer treatment projects in Illinois. The IEPA informed the Village projects already in the SRF process prior to the signing of the American Recovery and Reinvestment Act were receiving stimulus loans along with many sewer replacement projects requiring less time and expense for submittal.

Even if the Village could have secured a loan through the ARRA, it would still not make the project affordable according to our residents. We found that if the project would not be considered affordable with the stimulus loan, it would be irresponsible for the Village to spend the dollars necessary to pursue the SRF loan given the unlikely chance financing would be available.

While we are disappointed that stimulus funding will not provide the assistance we had hoped it would, we will continue to work with our national and state representatives to secure funding alternatives for this much needed infrastructure improvement. In closing I would like to thank the residents that have called and emailed me to address specific problems in their neighborhoods. Trustee John Huemann and I recently visited some residents on River Terrace Drive and Cardington Way in Chapel Hill Estates. Residents from both of these areas had emailed me wanting to discuss concerns in their neighborhoods. On Saturday, September 19, 2009, I will be walking Sunnyside Beach Drive between 9:00 a.m. to 3:00 p.m., weather permitting. If anyone shares similar concerns and wants to meet at a certain time or would like me to attend a subdivision association meeting, please email me at ehettermann@johnsburg.org. I am looking forward to meeting with our residents and addressing their concerns. Hope to see you at the Saufen und Spiel festivities. Come and join the fun.




### STORMWATER MANAGEMENT

DO'S AND DON'TS AROUND THE HOUSE

n urban and suburban areas, much of the land surface is covered with buildings and pavement, which do not allow rain and snowmelt to soak into the ground. Instead, most developed areas rely on storm drains to carry large amounts of runoff from roofs and paved areas to nearby waterways. The stormwater runoff carries pollutants such as oil, dirt, chemicals and lawn fertilizers directly to streams and rivers, where they seriously harm water quality. Here is a list of things everyone can do around the house to help protect surface and ground waters from pollution.

- Buy household chemicals only in the amount you expect to use and apply them as directed. More in not better. Take unwanted chemicals to hazardous waste collection centers; do not pour them down a drain.
   Never pour unwanted chemicals on the ground. Soil cannot purify most chemicals and they may eventually contaminate runoff.
- Use low-phosphate or phosphate -free detergents.
- Use water based products whenever possible.
- When landscaping your yard, select plants that have low requirements for water, fertilizers and pesticides.
- Preserve existing trees and plant trees and shrubs to help prevent erosion and promote infiltration of water into the soil.
- Leave lawn clippings on your lawn so that nutrients in the clippings are recycled and less yard waste goes to landfills.
- **Compost your yard trimmings**. Compost is a valuable soil conditioner which gradually releases nutrients to your lawn and garden.
- Spread mulch on bare ground to help prevent erosion and runoff.
- Inspect your septic system annually and have your septic system pumped regularly.
- **Do not divert storm drains** or basement pumps into septic system.
- Use low-flow faucets, shower heads, reduced-flow toilet flushing equipment and water saving appliances such as dish and clothes washers.
- Repair leaking faucets, toilets and pumps.
- Use dishwashers and clothes washers only when fully loaded.





centers. Never put used oil or other chemicals down storm drains or in drainage ditches.

One quart of oil can contaminate up to two million gallons of drinking water!



The Johnsburg Police Department is seeking the help from all of its residents. The Police Department has a better chance of apprehending these individuals if calls are made immediately.

School will be starting this month. Please drive slowly in neighborhoods and school zones. The speed limit on Johnsburg Rd in back of Bush School is 20 MPH when children are present. This includes the kids playing at recess and gym classes. Also be aware of students walking or riding their bikes to school and obey all crosswalk laws.


Starting Friday, September 11th thru Sunday, September 13th, Johnsburg is the place to be for Food, Music, Games and good old fashion fun!

### FINANCE COMMITTEE UPDATE

The Finance Committee recently recommended that the board move forward to refinance an existing debt through the use of General Obligation Alternate Revenue Source Bonds. In December of 2007, the Village refinanced an existing debt certificate in the amount of \$2.6 million, and at that time secured an additional \$2 million for the construction of the low-pressure sewer system being pursued. Unfortunately, due to the delay in construction, the Village must now return the unused \$2 million that was borrowed to cover its portion of the west side collection system project.

The Finance Committee compared the use of two municipal financing tools - debt certificates and bonds - to determine the most financially sound method to restructure the debt. Bonds will provide the Village a more competitive interest rate because they are backed by property taxes. The Village will repay this debt through general fund revenues such as sales tax, income tax and other fines and fees. Property taxes will not be used to repay this debt. The Village has an existing bond that is backed by property taxes. We have always abated the levy of taxes to pay the debt. What this means to you as a property tax payer is

that the Village has never increased your real estate taxes to pay the bonds. We will continue to abate the levy so that the debt is paid solely through other general fund revenues.

The Village will repay this debt through general fund revenues such as sales tax, income tax and other fines and fees. Property taxes will not be used to repay this debt.

In the near future, the Village Board will consider approving an ordinance to authorize the bonds. A public hearing will be held before adopting a final bond ordinance to refinance this debt.

### On the Horizon

In addition to our regular responsibilities, the Finance Committee is now working on a Strategic Plan that will include ways to improve the dissemination of financial information to our community. Check the village website, www.johnsburg.org, for future developments.

### FALL BRUSH PICKUP

The Johnsburg Public Works Department will be conducting a fall brush pickup throughout the Village starting September 28, 2009. All brush must be placed at the road by 7:00 a.m. on September 28st. Crews will only be going through subdivisions once so if your branches are not at the road when they go by they will not be picked up at a later time. All branches must have their cut ends closest to the road in a neat and orderly pile. All branches must be a minimum length of 4 feet and cannot exceed 6 inches in diameter. Anything that cannot be put through the chipper safely will not be taken. Evergreen cuttings must be kept separate from other tree branches and will be picked up separately. This service is being provided for larger tree and bush branches generated from trimming or storm damage and is not intended to dispose of whole trees that have been removed.
