# FROM THE VILLAGE PRESIDENT David G. Dominguez



As I remarked in the winter newsletter, this article would be my last as your Village President. It's amazing to think that 14 exciting years have flown by. I consider myself to be very fortunate to have served as Village President for this time period. The residents were great and supportive; the various board members worked together to resolve problems; and our planning efforts were excellent. We worked together to grow our community slowly and with purpose.

My job was busy but most of the work was refereeing – trying to ensure that residents with village issues were being treated fairly; and that ordinances were being equally applied. My next key responsibility was to represent the Village in endeavors that required Village presence. This required traveling throughout the county for early morning meetings, late night meetings, and those dreaded meetings that occurred during the work day. The last major responsibility was to see that the Village operated effectively in providing good service to our residents. Here I was fortunate to have a staff of people whose hard work made my job much easier.

Some of the key achievements attained during my time in office include:

- •Change of Facility Plan to Include Rte 31 Properties
- •The Development of the 2020 Land Use Plan
- •Reconstruction of Private Roads to Public Roads
- •Establishing a full time Public Works Department
- •Receiving a 1 Million Dollar Federal Grant for the Sewer Project
- •Ground Breaking and construction of Sewer plant
- •Achievement of Cost Savings by Using an Existing Building for the Sewer Plant
- •State Grant for Lift Station and Force Main •Border Agreements with Our Neighboring Communities
- •Approval of our FPA by the IEPA •Construction of the Water Tower

- Renovation of the Village HallObtaining a State Grant for Hiller Park's Construction
- •Construction of Hiller Park Concession Stand
- •Reconstruction of Johnsburg Road
- •Purchasing the Public Works Facility
- •Purchasing the Rescue Squad Facility and it's Renovations as a Police Department
- •Receiving \$2.6 Million in Additional Grants for the Sewer Facility
- •Obtaining 17 Acres for an Athletic Field
- •The Construction of our first major Retail Development in 30 Years.

I cannot claim being responsible for all of these achievements; rather board members, committee members, Village employees and the residents who served with me during my terms in office achieved these results.

Some of most memorable celebrations were those supporting other community endeavors, such as supporting the VFW Memorial Parade, the lighting of the Village Christmas Tree, or the Celebration of our 50th Anniversary of the incorporation of the Village. These proceeding got neighbors together and all enjoyed themselves.

My greatest achievement was having more than 50 residents participating in some function of the Village. I don't believe any other Village operates with that much participation.

There have been some disappointments along the way. The sewer project is one of those disappointments. Due to the severe economic downturn in the past year and a half and the high increase in costs resulting from the project's delay, the Village board has announced it will re-evaluate the sewer project looking closely at increased costs related to financing, material and labor, project scope changes, and the potential of new funding through the Federal Economic Stimulus package before moving forward with the project.

#### Message from the President Cont:

Had the project began as anticipated ,we could have been two years through the project and closer to the completion of Phase 1. Another project I had hoped would be further along is the acquisition of the right of way on Church Street. This is still in the works and will be resolved soon. Lastly, I had hoped to see more progress on the Metra train site. The Village is actively working on this project so that we can all benefit from this much needed regional transportation improvement.

The future is bright for Johnsburg. There will be good news about additional business development on Route 31announced shortly. With that development, you will continue to see improvements to Route 31. Likewise, we'll see improvements at the intersection of Chapel Hill Road, Johnsburg Road and St. Johns Road as McHenry County pursues its plans to improve traffic flow at that intersection. If we are fortunate, we will acquire some grant money for additional sidewalks throughout town This is truly ironic. When we placed the first sidewalks along Johnsburg Road, residents asked if we were nuts, believing that we were just wasting money. Today we receive many calls and letters inquiring when sidewalks can be placed in other parts of town.

We made great strides in the past 14 years, and more will come. I know this because I live in a town that cares about its residents, businesses, homes and its community. It's been a real pleasure to serve as your Village President. If you see me in town or in the yard, stop by and we can talk about how they did it in the old days.

## **CHURCH STREET**

Village officials and staff are frequently asked why the Village does not repair the potholes on Church Street located west of the intersection of St. Johns Avenue. Please be aware that section of roadway is situated on private property and is not a Village road. Statutes prohibit the Village from expending public funds on private roads therefore we cannot perform repairs to the roadway. The Village has been working with both St. John the Baptist Church and the Johnsburg Community Club to acquire the road through a right of way dedication. Once the area is dedicated to the Village,

maintenance repairs can be done and plans to improve the roadway can be pursued. We appreciate your concerns regarding the condition of the road and ask that you travel cautiously through the area. Your patience in this matter is greatly appreciated.

For the 3<sup>rd</sup> time in the past year, members of the Community Club Mike Clark, John Clark, Trustee John Huemann, Jeff Huemann, Trustee Ed Hettermann, Jeff Meyers, Marty Palmer and Allen Stilling, donated their time on February 28 to patch potholes on Church Street. The Huemann's donated the use of their backhoe and Rick Quinn donated a semi load of gravel to help with the repairs on Church Street. Many thanks to the Community Club and its members for their outstanding efforts.

## **COMMUNITY AFFAIRS COMMITTEE**

As we are fast approaching the end of fiscal year 2008, the Community Affairs Committee is heavily focused on the year ahead. But first I would like to recap some of our important accomplishments in 2008.

First, Hiller Park baseball fields have undergone a remarkable transformation. The "Showcase" field now sports a new warning track and permanent "green" screening (buffer zone) behind the center field fence line. The Bronco field, used by teams ranging in ages between 9-14, saw even bigger changes. The entire infield was re-graded and moved back 20 feet toward the backstop and the walking path that previously encroached upon the left field foul territory has been relocated to allow for unobstructed play. Due to recent equipment purchases and manpower commitment, the overall maintenance and condition of the fields have improved dramatically. Look for more Hiller Park improvements this spring.

Second, the recent construction of the new Johnsburg Community Park shelter was the first phase of a multistage plan for the build out of Johnsburg's newest park, located in the Jak-Anna subdivision just west of the Community Club. The shelter's design and orientation was carefully chosen to permit passive gatherings for centralized "in-town" activities. Again we would like to thank Representative Jack Franks for his efforts in helping the village secure a state grant for the purpose of constructing the park shelter. One day this park could serve as the social epicenter of Johnsburg.

Next, I'd like to congratulate our social affairs subcommittee on the planning and execution of another hugely successful "Celebration in the Park" community fall festival. Residents turned out in large numbers to enjoy live music, food, fun and fireworks that were second to none.

And finally, Jill McEvoy, Ellen Bathje and the rest of the Community Affairs Committee would like to thank all those who braved the arctic temperatures and gale force winds to attend our family Holiday Celebration at Sunnyside Park. Unfortunately, the outdoor evening event fell victim to December's blistery winter weather, which proved to be fit for neither man nor beast. A special thanks goes out to Johnsburg's Turtle Soup Company as well as Chase Bank for volunteering. The highlight of the event were special guests, Mr. and Mrs. Santa Clause, who listened to Christmas requests from hopeful little ones whose enthusiasm was in no way diminished by the frigid wind chill. Many thanks to the fire department, Johnsburg Police, Village staff and volunteers for their efforts in making this evening possible.

Now, for a look ahead. In 2009, our ambitious 2012 goals, as outlined in the Community Affair Committee Strategic Plan, voted on and approved last year, will be carefully reviewed and updated to reflect the current economic realities facing the Village and its residents. Although we will forge ahead wherever possible, we must remain flexible and consider possible modifications to allow for prudent and responsible decision making.

•Implementation of a newly designed website and newsletter.

•Further development of our comprehensive park plan.

•Fully integrated community calendar of events.

#### **NEWS FROM PUBLIC WORKS AND THE BUILDING DEPARTMENT**

#### **Building Permits**

Spring will be here before you know it, now is the time to start planning for that remodeling project, shed, deck or any other home improvements you may be considering. Since a Building Permit is required for home improvements, applying for the necessary permits early will help alleviate delays in getting your permit on time to start the project. Please be aware that during the spring and summer months, it may take as long as 30 working days to receive a permit, depending on the work being done. Building permits are issued in the order that they are applied for.

#### Swimming Pools — When is a Barrier Required?

There have been a lot of questions over the last couple years regarding swimming pool barriers. By definition, an outdoor swimming pool is any structure or device intended for swimming or recreational bathing (both permanent and temporary) that has a <u>sidewall of 24 inches or greater</u>. This includes in-ground, above ground and on-ground pools, hot tubs and spas. Within the Village there are many inflatable pools that are taken down every year. Since temporary pools do not require a building permit to install, many believe that the barrier requirements do not apply. **This is not the case.** Village Ordinance requires a 48 inch barrier around any swimming pool, whether it is permanent or a temporary, inflatable pool. If the pool walls are 48 inches above grade, they will act as their own barrier and no other barrier is required. The purpose behind the barrier regulation is to make sure a child does not have access to the pool. The Village strongly enforces this regulation because it helps keep our neighborhoods safe for our children. Notices will be sent to those residents who are found to be in violation and a timeframe will be given to comply. ## **Illinois Safe Routes to School Update**

Our Safe Routes To School (SRTS) application was submitted at the end of 2008. The decision by the SRTS Committee is slated for the next 2-3 months. The Safe Routes to School concept began in the late 1970s in Odense, Denmark over concern for the city's pedestrian accident rate. The town implemented a number of improvements including a network of pedestrian and bicycle paths, slow speed areas, narrowed roads and traffic islands. The result was an 85% reduction in traffic injuries to children. Because of the success of the program in Denmark, the SRTS concept spread internationally, with programs developing throughout Europe, Australia, New Zealand, Canada and the United States. The first SRTS program in the United States was started in 1997. In August 2005, federal transportation legislation devoted \$612 million for The National SRTS Program from 2005 through 2009. It is this program that funds Illinois' Safe Routes to School Program.

Currently, Julia Gasior from the Johnsburg High School Advanced Placement Government Class is working on a research project to develop a volunteer plan for bike and safety assistance programs. The Village, District 12 and volunteers working together are the foundation for this project to succeed. SRTS application acceptance is limited but the Village will be able to reapply should our application not be chosen this year. Needless to say this is a long term project and goal of the Village, the School District, residents and students such as Ms. Gasior, which will truly benefit the community. The Village, along with District 12, will once again participate in the **2009 International Walk to School Day** which will take place on **Wednesday October 7, 2009. Mark your calendar!!**

## How Local Government Works In Johnsburg

Oftentimes, people wonder how local government works. The Village of Johnsburg is unique in that our structure incorporates the thoughts and ideas of more than 50 people in the decision making process. Currently seven committees, with the assistance of Village staff, research and obtain public input and provide recommendations regarding Village matters. By utilizing committees made up of residents of the Village who bring their own experiences and expertise, the Village Board receives recommendations based on the ideas and knowledge from a broad spectrum of our community.

Our Village is made up of the following committees: Public Works, Ordinance, Finance, Community Affairs, Development and Governmental Affairs, Planning and Zoning, and Economic Development. Matters that come before the Village Board are often first reviewed at one of these committees. If you have an issue that needs attention by the Village, the best course of action is to contact Village Hall so that you can be directed on how to proceed.

The public is encouraged to ask questions, voice concerns and provide input and supporting information at the committee level. Once the proper committee has reviewed and discussed all of the information, a recommendation is made to the Village Board. The Village Board, consisting of six Trustees and the Village President, will then consider the committee's recommendation, along with all of the information provided at the committee meeting, including any input from Village staff, before making a final decision.

In addition there are three committees that work in concert with the Village. They are the Johnsburg Community Action Network (JCAN), Johnsburg Police Pension Committee and the Johnsburg Police Commission.

The Village welcomes all its residents to get involved in their local government. Volunteering for a village committee is the best place to begin serving your Village. Here, you will have the opportunity to participate in making decisions that will steer the course of the village as well as solving everyday problems. The valuable knowledge and experience you will gain by serving on these committees will provide you with an in-depth understanding of Village issues and operations. Dear Ms. Hutchinson and Mr. Bennett:

This is in response to your letter of March 17, 2008, to the U.S. Environmental Protection Agency's Administrator Stephen Johnson requesting support of the Johnsburg's Waste Water Conveyance and Treatment Works project. Your correspondence was forwarded to me for response. This also provides follow up to Mr. Phil Zahreddine's letter to you dated April 16,2008.

The Fox River, along which the Village of Johnsburg is located, is an Illinois water resource much utilized for recreation including fishing, swimming and canoeing. It is also listed as impaired due to low dissolved oxygen levels. This project will replace septic systems with a sewer and treatment system. Septic systems located close to the Fox River, on small land areas and in unsuitable soils with high ground water conditions can adversely affect water quality. The operation of septic systems under these conditions can lead to both the deterioration of ground water and nearby surface waters due to excess nutrient and bacteria levels.

The U.S. Environmental Protection Agency is presently examining ways to reduce nutrient loading to the central Mississippi River basin in an effort to reduce the Aquatic life dead zone caused by a lack of oxygen in the Gulf of Mexico. This area of the Gulf of Mexico is referred to as the hypoxia zone. The Fox River waters eventually end up as part of the nutrient loading to the Mississippi River and the Gulf of Mexico. Also, any reduction of nutrients to the immediate area will result in less local nutrient loading which can improve the oxygen levels of the Fox River. Thus, this project is part of a solution to both a local and national pollution problem.

For these reasons please register our position in support of Johnsburg's Waste Water Conveyance and Treatment Works Project.

# JOHNSBURG BUSINESS SPOTLIGHT

The Economic Development Committee continues business spotlight series with interviews with Johnsburg business owners. In this edition the Committee interviewed\_Mr. Phil Bartmann of Radicom Inc. located at 2604 North Chapel Hill Road\_in Johnsburg.

Phil and Janice (Wakitsch) Bartmann moved to Johnsburg in 1965 Janice moved to Johnsburg with her family in 1952. They love living along the banks of the Fox River in Johnsburg as they are avid boaters. All of the Bartmann children were raised and educated in Johnsburg schools. In 1969, when Radicom moved to Johnsburg, it was a CB radio and scanner shop and also maintained GE two way radios for many businesses in the area. When cellular services came along Radicom became a Cellular One dealer and eventually became a Nextel agent. At one point they operated three stores, plus the main corporate headquarters here in Johnsburg. Municipal, governmental and commercial users are the main entities that they do business with today. Their main business is selling and servicing two way radios and telephone systems for various police and fire departments and businesses.

Radicom has installed many 911 dispatch centers in Lake and McHenry county. Currently Radicom has 15 employees, 7 of whom are service technicians. Radicom also offers a variety of commercial telephone systems for a wide range of businesses. Radicom, Inc. also provide<u>s</u> long distance and T1 service. Mr. Bartmann stated that there have been so many changes in the communications industry, that it has become a full time job keeping up with the new technology.

The majority of Radicom's clients are within 90 minutes of the Johnsburg area. Radicom's large client base includes the Chicago Transit Authority, the Lake County Sheriff's Department, the Walworth County Sheriff's Department, the Village of Johnsburg and many other public safety agencies and businesses.

Mr. Bartmann serves on the Board of Director for the Fox Waterway Agency. He is running\_this year for reelection. He is very proud to represent Johnsburg and the surrounding area on the Waterway Agency. Mr. Bartmann is also a long standing Trustee for the McHenry Township Fire\_Protection District where he served as an active firefighter for 30 years.

Mr. Bartmann spoke of how his business is constantly looking for new products. Radicom has recently installed a new and modern dispatch center for the McHenry Police Department. The Village of Johnsburg Police Department is dispatched through this Center.

Mr. Bartmann enjoys living and having his business in Johnsburg so much that he includes "Johnsburg" as the location of his business on his letterhead.

Like many residents, Mr. Bartmann would like to keep the small town atmosphere\_here and likes the fact that the Village and its Committees are here for the residents.
