Good Afternoon:

Just wanted to update you on some items from last nights Sports Organization meeting. Here is an outline of events:

1) Field Use Agreement discussion & concerns:

a) Would like the agreement to be based seasonally instead of calendar year. The reasoning for this is that many of

the organizations have a spring & fall season with many different factors regarding the number of individuals who

try out in each separate season (meaning 2 different rosters).

b) Under definitions of Local Sports Organization's, it was mentioned that we may want to include the names of our

local organizations, considering many of them do not have 100% of their members living within the Johnsburg Dist 12

School District, therefore, none of the organizations fit into that definition as it reads now.

c) Mr Tom Ross, District 12 Athletic Director, asked if District 12 would be obligated to pay the Field Uses. I mentioned that

I believe the board exempted them from the Field Use Agreements but that I would confirm that.

2) Previous Improvements/Recommendations:

a) We had previously come to some recommended short term goals which have not been completed which are still of interest

to all Sports Organizations. The 2 main improvements being a handicap access of some kind at the Jr High School fields and

the gravel parking lot behind the transportation building at the Johnsburg High School.

b) I will email Dan Johnson to see if we are still able to go forward with these items and then work on coordinating with

the Sports Organizations, Dist 12 and Tim Hartnet (if possible) on a plan of action.

3) Expansion of Hiller/Open Space:

a) This was by far the main topic of discussion for the evening. All of the Sports Organizations along with Tom Ross,

District 12 representative agree that we do not have enough space for the majority of our sporting events. Everyone would

love to see a push for a Hiller Expansion. I did let them know that the Village has been working on this, however, every time

we think we may be making strides its like we go two steps back. Everyone in the room was adamant about trying to push for this harder.

b) There was also some discussion on the Soccer Kiddie Kicker Leagues and The Flag Football Leagues sharing the Hiller Fields.

The Soccer & Football Organizations will coordinate this effort before giving the Village their schedules.

c) It was also mentioned that we could possibly see if the High School JV Soccer team would use the Hiller Park fields for their

4/5 home games and allow the Johnsburg Jr Skyhawks to use the JV Soccer field therefore opening more space for practice and

possible an extra game field
