## ORDINANCE NO. 2016-17-36

## An Ordinance Amending Certain Sections of Chapter 12, Nuisances, of the Johnsburg Municipal Code

BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: That Section 12.02B Public Nuisances Affecting Health, Paragraph 11of the Johnsburg Municipal Code is hereby amended as follows:

11. The deposit of garbage, rubbish, snow, leaves or any offensive substance in or on any street, sidewalk, waterway and channels, public places, or on any private property, except as may be permitted by ordinance;

SECTION 2: That Section 12.02D, Public Nuisances Affecting Safety, Paragraph 17 of the Johnsburg Municipal Code, is hereby amended to read as follows:

17. The unenclosed or unsheltered storage or standing of any one or more items of tangible personal property that is either not registered, abandoned, discarded, unused, stripped, junked, wrecked, dismantled, scrapped, salvaged, not in running condition or not in good and safe operating condition for a period of 7 days. Such tangible personal property includes but is not limited to vehicles, boats, trailers, recreational vehicles and campers, machinery, implements and/or equipment, lumber and wood, junk, trash and debris, paper, tires and batteries, furniture and appliances, building materials, plastics, metals, and any other ferrous or nonferrous material, goods or articles of any kind within the corporate limits of the Village All-unsheltered storage of old, unused, stripped, junked, boats, trailers, recreational vehicles, recreational campers and automobiles not in good and safe operating condition, and of any other vehicles, machinery, implements and/or equipment and personal property of any kind which is no longer safely usable for the purposes for which it was manufactured, within the corporate limits of this Village;

Acceptable shelters/enclosures in which to store items of personal property shall be permanent structures enclosed on all sides with a floor and roof a. unsheltered storage defined: to allow or maintain an article, from 12.02.D.17, to be kept not inside a permanent structure with foundation.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
