Ordinance 16-17-40
An Ordinance Authorizing the Sale of Public Property
Owned by the Village of Johnsburg

WHEREAS, the **Village of Johnsburg**, McHenry County, Illinois, is in the opinion of a simple majority of the corporate authorities of the **Village of Johnsburg**, McHenry County, Illinois, and as provided in 65 ILCS 5/11-76-4 and:

WHEREAS, in the opinion of the corporate authorities of the **Village of Johnsburg**, it is no longer necessary or useful to or for the best interests of the **Village of Johnsburg** to retain ownership of the public property hereinafter described; and

WHEREAS, it has been determined by the Village President and Board of Trustees of the **Village of Johnsburg** to sell said public property for cash.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF JOHNSBURG, as follows:

SECTION 1: The Village President and Board of Trustees of the **Village of Johnsburg** find that the following described public property now owned by said jurisdiction is no longer necessary to said jurisdiction and said jurisdiction would be best served by the said public property sale:

Previously Used by Public Works Department

SECTION 2: The Village Administrator is hereby authorized and directed to sell via public auction utilizing the services, if necessary, of Obenauf Auction Services the herein named items now owned by the Village of Johnsburg.

SECTION 3: Upon payment in full, the Village Administrator is hereby authorized and directed to convey and/or transfer the aforesaid property to the respective buyer.

SECTION 4: This ordinance shall be in full force and effect from and after its passage by the corporate authorities.

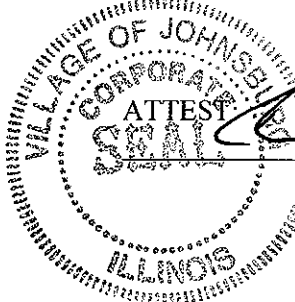
