ORDINANCE NO. 17-18-06

An Ordinance Granting a Variance to Section 7
Accessory Buildings and Structures for the property commonly
Known as 1707 River Terrace Drive, Johnsburg, Illinois

WHEREAS, Mark Popiel filed with the Village Clerk of the Village of Johnsburg, McHenry County, Illinois, a request for variances to Section 7 Accessory Buildings and Structures for the property commonly known as 1707 River Terrace Drive, Johnsburg, Illinois.

WHEREAS, the applicant requested that a variance be granted to Section 7.1-2, Accessory Buildings and Structures to accommodate the construction of a shed on the property prior to the construction of a principal building.

WHEREAS, A PUBLIC HEARING was held by the Planning & Zoning Commission, after due notice in the manner provided by law; and

WHEREAS, THE PLANNING & ZONING COMMISSION, has, upon holding a hearing, made a report of said request to the Village Board; and

WHEREAS, THE VILLAGE BOARD has reviewed the minutes put forth by the Planning & Zoning Commission and based upon the Commission's findings that the granting of the variance is in harmony with the general purpose and intent of the Zoning Code and that the zoning request is consistent with the primary use and zoning of the area.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF JOHNSBURG, McHenry County, Illinois, as follows:

SECTION 1: That a variance be granted to Section 7.1-2 of the Johnsburg Zoning Ordinance to permit the construction of a shed on the property commonly known as 1707 River Terrace Drive prior to the construction of a principal building contingent upon a residential home being built on the property within three years from the approval date. Should a home not be built within the three year period, the applicant is must publish notice as required by the Johnsburg Zoning Ordinance and return back before the Planning and Zoning Commission to request consideration of an extension.

SECTION 2: That all requirements set forth in the Zoning Ordinance of the Village of Johnsburg, as would be required by any owner of property zoned in the same manner as the Subject Property, shall be complied with, except as otherwise provided in this Ordinance.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid,

such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 6: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 7: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
