ORDINANCE NO. 2017-18-13

An Ordinance Amending Certain Sections of Chapter 9, Liquor Control and Liquor Licensing, of the Johnsburg Municipal Code

BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: That Section 9.08 B, License Classifications and Fees of the Johnsburg Municipal Code, is hereby amended to read as follows:

B License Classification and Fees. There shall be not more than the following number of licenses per class of license and the following fees shall be paid upon application for a new or renewed license:

1. Class A: Seven ~~(7)~~ Eight (8)
2. Class A-1: Six (6)
3. Class B: Five (5)
4. Class C: Three (3)
5. Class E: One (1)

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.


