ORDINANCE NO. 17-18-17

An Ordinance Approving the Jurisdictional Transfer of a portion of Old Bay Road by the Village of Lakemoor to the Village of Johnsburg, McHenry County, Illinois

WHEREAS, the Village of Johnsburg is a non-home rule duly recognized Illinois municipal corporation under the Illinois Constitution of 1970; and

WHEREAS, the Village of Johnsburg is authorized under 605 ILCS 5/4-409 to contract with other authorities regarding the jurisdiction, maintenance, administration, engineering or improvement of any roadway or portion thereof; and

WHEREAS, the Village of Johnsburg has agreed to accept the transfer of said roadway jurisdiction as set forth in an Intergovernmental agreement entered into with the Village of Lakemoor, and the County of McHenry as part of the full and final settlement of McHenry County Circuit Court Case Number 14CH535, and

WHEREAS, the conditions precedent to the approval of this Ordinance under the Intergovernmental Agreement have been met.

NOW THEREFORE BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: The above recitals are incorporated herein.

SECTION 2: The Board of Trustees of the Village of Johnsburg hereby approve this Ordinance, to be attached to the Local Agency Agreement for Jurisdictional Transfer, to effectuate the jurisdictional transfer of 950 feet of Old Bay Road to the Village of Johnsburg as depicted in Exhibit A attached hereto. To that end, the President and Clerk are hereby authorized to execute the Local Agency Agreement for Jurisdictional Transfer and deliver same to the Village of Lakemoor and the Illinois Department of Transportation.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.


