ORDINANCE 15-16-26
An Ordinance Amending Chapter 20, Open Burning of Landscape Waste
of the Johnsburg Municipal Code

SECTION 1: That Chapter 20 be amended to add 20.02 Penalty as follows:

20.02 Penalty - Any person, firm or corporation violating any provision of this Chapter 20 shall be fined not less than a Class C and be responsible for the Village cost of prosecution including reasonable attorney fees.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.


