**ORDINANCE NO. 2018-19-08**

**An Ordinance Amending Chapter 15 Traffic, of the Johnsburg Municipal Code,  
Adding Section 15.18, No Left Turn**

BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: That Chapter 15, Traffic of the Johnsburg Municipal Code be amended to add Section 15.18 No Left Turn as follows:

**15.18 NO LEFT TURN.** Left turns are prohibited from the following streets:

- Westbound Fairview at Chapel Hill Road
- Eastbound Fairview at Chapel Hill Road

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
