ORDINANCE NO. 2018-19-21

An Ordinance Abating Taxes Levied to Pay Principal and Interest on General Obligation Waterworks and Sewerage Refunding Bonds (Alternate Revenue Source) Series 2018, in the Village of Johnsburg for the 2018 Tax Year

WHEREAS, the President and Board of Trustees (the "Board") of the Village of Johnsburg, McHenry County, Illinois (the "Issuer"), by Ordinance 2018-19-13 (the "Ordinance") passed on the 2nd day of October, 2018, did provide for the issuance of \$1,585,000 waterworks and sewerage refunding bonds (alternate revenue source), Series 2018, (the "Bonds") to refinance outstanding General Obligation Waterworks and Sewerage Refunding Bonds, Series 2009; and

WHEREAS, the Ordinance provided for the levy of a direct annual tax sufficient to pay principal and interest on the Bonds; and

WHEREAS, the Issuer will have Pledged Revenues (as defined in the Ordinance) available for the purpose of paying the debt service due on the Bonds during the next succeeding bond year; and

WHEREAS, it is necessary and in the best interest of the Issuer that the tax heretofore levied for the year 2018 to pay such debt service on the Bonds be abated.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF JOHNSBURG, McHenry County, Illinois, as follows:

SECTION 1: The Pledged Taxes heretofore levied in the Ordinance for 2018 shall be abated as follows:

<u>Year</u>	<u>Amount Levied</u>	<u>Amount to be Abated</u>	<u>Remainder of Tax to be Extended</u>

SECTION 2: Except for the levy to pay the principal and interest on the bonds as described above, no other levy imposed by the Board is to be affected by this Ordinance.

SECTION 3: Upon the passage of this Ordinance, the Clerk shall file a certified copy of this ordinance with the McHenry County Clerk, and it shall be the duty of the McHenry County Clerk to abate said tax levied for the year 2018 in accordance with the provisions hereof.

SECTION 4: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 5: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 6: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
