ORDINANCE NO. 18-19-20

An Ordinance Granting a Variance to Section 11.5-3 Required Setbacks of the Johnsburg Zoning Ordinance, for the property commonly Known as 2411 Johnsburg Road, Johnsburg, Illinois

WHEREAS, Fritz Larsen filed with the Village Clerk of the Village of Johnsburg, McHenry County, Illinois, a request for a variance to Section 11.5-3 Required Setbacks of the Zoning Ordinance for the property commonly known as 2411 Johnsburg Road, Johnsburg, Illinois.

WHEREAS, Mr. Larsen requested that the Planning and Zoning Commission for the Village of Johnsburg recommend that a variance be granted to Section 11.5-3.1 Required Setbacks, to permit a front yard setback of 15 feet in lieu of the otherwise required 60 feet to permit the placement of a commercial accessible ramp.

WHEREAS, A PUBLIC HEARING was held by the Planning & Zoning Commission, after due notice in the manner provided by law; and

WHEREAS, THE PLANNING & ZONING COMMISSION, has, upon holding a hearing, made a report of said request to the Village Board; and

WHEREAS, THE VILLAGE BOARD has reviewed the minutes put forth by the Planning & Zoning Commission and based upon the Commission's findings that the granting of the variance is in harmony with the general purpose and intent of the Zoning Code and is consistent with the primary use and zoning of the area.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF JOHNSBURG, McHenry County, Illinois, as follows:

SECTION 1: That a variance is granted to Section 11.5-3.1 Required Setbacks, to permit a front yard setback of 15 feet in lieu of the otherwise required 60 feet.

SECTION 2: That said variance is granted to permit the placement of a commercial accessible ramp.

SECTION 3: That all requirements set forth in the Zoning Ordinance of the Village of Johnsburg, as would be required by any owner of property zoned in the same manner as the Subject Property, shall be complied with, except as otherwise provided in this Ordinance.

SECTION 4: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 5: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 6: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
