## **ORDINANCE NO. 18-19-38**

An Ordinance Granting a Variance to Section 7.3 Pools, and Section 7.1-4 and 7.1-7 Accessory Structures of the Johnsburg Zoning Ordinance for the property Commonly Known as 4505 Farmington Lane, Johnsburg, Illinois

WHEREAS, Tom Benck on behalf of the Tracy A. Benck Trust, filed with the Village Clerk of the Village of Johnsburg, McHenry County, Illinois, a request for a variance to Section 7.3 Pools, and 7.1-4 and 7.1-7 Accessory Structures of the Johnsburg Zoning Ordinance to permit an in-ground pool, pool house and associated structures in the front yard, in front of the principal building for the property commonly known as 4505 Farmington Lane, Johnsburg, Illinois 60051. Said pool house shall be 1,216 square feet in size in lieu of the otherwise permitted 400 square, and shall only be utilized as an accessory to the pool and not as a single-family dwelling;

WHEREAS, A PUBLIC HEARING was held by the Planning & Zoning Commission, after due notice in the manner provided by law; and

WHEREAS, THE PLANNING & ZONING COMMISSION, has, upon holding a hearing, made a report of said request to the Village Board; and

WHEREAS, THE VILLAGE BOARD has reviewed the minutes put forth by the Planning & Zoning Commission and based upon the Commission's findings has determined that the granting of the requested variance is in harmony with the general purpose and intent of the Zoning Code;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF JOHNSBURG, McHenry County, Illinois, as follows:

SECTION 1: That a variance be granted to Section 7.3 Pools, and 7.1-4 and 7.1-7 Accessory Structures of the Johnsburg Zoning Ordinance to permit an in-ground pool, pool house and associated structures in the front yard, in front of the principal building for the property commonly known as 4505 Farmington Lane, Johnsburg, Illinois 60051. Said pool house shall be 1,216 square feet in size in lieu of the otherwise permitted 400 square, and shall only be utilized as an accessory to the pool and not as a single-family dwelling;

SECTION 2: That all requirements set forth in the Zoning Ordinance of the Village of Johnsburg, as would be required by any owner of property zoned in the same manner as the Subject Property, shall be complied with, except as otherwise provided in this Ordinance.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
