ORDINANCE NO. 20-21-19

***An Ordinance Annexing Certain Property Known as
4104 Spring Grove Road to the Village of Johnsburg***

WHEREAS, a written petition, signed by the legal owners and electors of record of land within the territory hereinafter described, being identified as Jeffrey and Stacy Callahan (the "Owner") has been filed with the Village Clerk of the Village of Johnsburg, McHenry County, Illinois, requesting that said territory be annexed to the Village of Johnsburg; and

WHEREAS, said territory is not within the corporate limits of any other municipality, other than the County of McHenry, and is contiguous to the corporate boundaries of the Village of Johnsburg; and

WHEREAS, the Village provides neither a public library or fire protection services; and

WHEREAS, all petitions, documents and other necessary legal requirements are in full compliance with the statutes of the State of Illinois, including but not limited to, 65 ILCS 5/7-1-8; and

WHEREAS, it is in the best interests of the Village of Johnsburg that said territory be annexed thereto.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF JOHNSBURG, McHenry County, Illinois, as follows:

SECTION 1: That the territory legally depicted and described in Exhibit A is hereby annexed to the Village of Johnsburg, McHenry County, Illinois.

SECTION 2: That the Village Clerk of the Village of Johnsburg is hereby directed to record in the Office of the Recorder and to file in the Office of the County Clerk of McHenry County, Illinois, and the post office serving the territory within 30 days of the effective date of this Ordinance, a certified copy of this Ordinance, together with a plat of annexation, attached hereto and made a part hereof.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment

shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

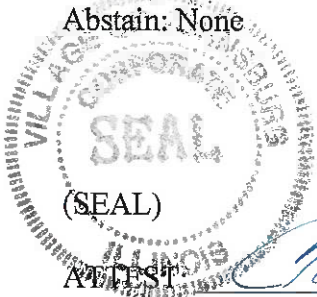
SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.


