ORDINANCE NO. 20-21-20

An Ordinance Zoning Certain Territory Commonly Known as 4104 Spring Grove Road R-1 Residential and A-1 Agricultural District Zoning

WHEREAS, a petition signed by Jeffrey and Stacy Callahan (the "Owners") has been filed with the Village Clerk of the Village of Johnsburg, McHenry County, Illinois, requesting that upon annexation into the Village, certain territory legally depicted and described in Exhibit A, attached hereto and made a part hereof (the "Subject Property") be rezoned as follows: the northwest 22,000 square feet (measuring 110 x 200 feet) be zoned Village of Johnsburg R-1, Residential District Zoning; and the remaining approximately 4.5 acres be zoned Village of Johnsburg A-1 Agricultural District Zoning.

WHEREAS, A PUBLIC HEARING was held by the Planning and Zoning Commission, after due notice in the manner provided by law; and

WHEREAS, THE PLANNING AND ZONING COMMISSION has, upon holding a hearing, made a report to the Village Board; and

WHEREAS, THE VILLAGE BOARD has reviewed the report put forth by the Planning and Zoning Commission and based upon the Commission's findings that the granting of the zoning will not impair an adequate supply of light and air to the adjacent property; will not unreasonably increase congestion in the public streets or otherwise endanger public safety; is in harmony with the general purpose and intent of the Zoning Code and that the zoning request is consistent with the primary use and zoning of the area.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF JOHNSBURG, McHenry County, Illinois, as follows:

SECTION 1: The Subject Property, legally depicted and described in Exhibit A, attached hereto and made a part hereof by this reference, shall be zoned as follows: the northwest 22,000 square feet (measuring 110 x 200 feet) be zoned R-1, Residential District Zoning; and the remaining approximately 4.5 acres be zoned A-1 Agricultural District Zoning.

SECTION 2: That all requirements set forth in the Zoning Ordinance of the Village of Johnsburg, as would be required by any owner of property zoned in the same manner as the Subject Property, shall be complied with, except as otherwise provided in this Ordinance.

Callahan Zoning Ordinance

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
