**ORDINANCE NO. 2020-21-40**

***An Ordinance Amending Certain Sections of Chapter 12, Nuisances  
of the Johnsburg Municipal Code***

BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: That Section 12.06 of Chapter 12 Nuisances be amended as follows:

**12.06 PARKING ~~MOBILE HOME~~ MOTORHOMES, RECREATIONAL VEHICLES, TRAILERS, and BOATS.**

~~A. Motor homes, boats, trailers and campers may be parked on driveways and private property limited to one of each type vehicle, when such vehicles have current registration. Motor homes, boats, trailers and campers may be parked on a driveway, side yard or rear yard only.~~

A. Motor homes, recreational vehicles, campers, trailers and boats and other watercraft such as by way of examples jet skis may be parked on driveways and the side or rear yard only on private property limited to a maximum of four (4) types or like-kind, when such vehicles have current registration with the Illinois Department of Motor Vehicles. Motor homes, recreational vehicles, campers, trailers and boats may be parked on a driveway, side yard or rear yard only.

B. Persons owning a mobile home motor home, recreational vehicle or camper parked on their property in accordance with the requirements herein within the Village shall register the mobile home said vehicle with the Village Clerk. No mobile home motor home, recreational vehicle or camper shall be used for sleeping purposes while parked or stored in the Village, except as provided in this section.

C. Guests of any owner or guest of any occupant of any dwelling in the Village may park a mobile home motor home, recreational vehicle or camper in the side or rear yard of such private property for not more than five seven (7) days, provided the mobile home motorhome is used for sleeping purposes only during such period.

Nothing in this Ordinance shall negate or supersede any recorded subdivision restrictive covenant or condition regulating the parking of vehicles, motor homes, recreational vehicles, campers, trailers and boats.

Penalties: Each person who violates of any provision of this section 12.06 shall pay a fine in the amount set forth in Class C of sector penalties of the Municipal Code.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment

shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.

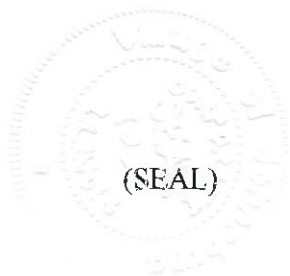
