## **ORDINANCE NO. 22-23-03**

An Ordinance Repealing Section 7.06, Tag Days – Soliciting Funds, and Repealing Section 10.12, Highway Solicitation of the Johnsburg Municipal Code

BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: Section 7.06, Tag Days – Soliciting Funds, of the Johnsburg Municipal Code is hereby repealed and the remaining subsections shall be renumbered accordingly, as well as any references to those sections in the Johnsburg Municipal Code.

SECTION2: Section 10.12 – Highway Solicitation, of the Johnsburg Municipal Code is hereby repealed and the remaining subsections shall be renumbered accordingly, as well as any references to those sections in the Johnsburg Municipal Code.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
