ORDINANCE NO. 22-23-11

An Ordinance Amending Chapter 12.06A and Chapter 15.9F Related to Parking Limitations on Driveways and Private Property of the Johnsburg Municipal Code

BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: Section 12.06A Parking Motorhomes, Recreational Vehicles, Trailers and Boats shall be amended as follows:

12.06 PARKING MOTORHOMES, RECREATIONAL VEHICLES, TRAILERS, and BOATS.

- A. Motor homes, recreational vehicles, campers, trailers and boats and other watercraft such as by way of examples jet skis may be parked on driveways and the side or rear yard only on private property limited to a maximum of four (4) ~~types or like kind~~, when such vehicles have current registration with the Illinois Department of Motor Vehicles registered under the resident's name at the subject address. Motor homes, recreational vehicles, campers, trailers and boats may be parked on a driveway, side yard or rear yard only.

SECTION 2: Chapter 15.9F(1) Parking Limitations on Driveways and Private Property shall be amended as follows:

~~F. Parking Limitations on Driveways and Private Property.~~

- ~~1. Residents and their guests may park operable, private, personal, non-business and non-commercial vehicle on their driveway overnight. If the driveway does not provide sufficient space such vehicles may be parked on the adjacent Village streets by notifying the Village Police Department in advance of such parking overnight for special occasions and driveway repair.~~

F. Parking Limitations on Driveways and Private Property.

1. Residents and their guests may park operable vehicles weighing 12,000 pounds or less on their driveway overnight. In the case of driveway repairs or special events/occasions when the driveway does not provide sufficient space for overnight parking, such vehicles may be temporarily parked in the front yard or along the adjacent Village street by obtaining authorization from the Village Police Department in advance of such parking. Said authorization shall be limited to 6 events per calendar year and shall be limited in duration as determined by the Village Police Department.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.


