**Ordinance 22-23-28**  
**An Ordinance Authorizing the Sale of Surplus Public Property**  
**Owned by the Village of Johnsburg**

**WHEREAS**, the **Village of Johnsburg**, McHenry County, Illinois, is in the opinion of a simple majority of the corporate authorities of the Village of Johnsburg, McHenry County, Illinois, and as provided in 65 ILCS 5/11-76-4 and:

**WHEREAS**, in the opinion of the corporate authorities of the **Village of Johnsburg**, it is no longer necessary or useful to or for the best interests of the **Village of Johnsburg** to retain ownership of the public property hereinafter described; and

**WHEREAS**, it has been determined by the Village President and Board of Trustees of the **Village of Johnsburg** to sell said public property for cash.

**NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF JOHNSBURG**, as follows:

**SECTION 1:** The Village President and Board of Trustees of the **Village of Johnsburg** find that the following described public property now owned by said jurisdiction is no longer necessary to said jurisdiction and said jurisdiction would be best served by the said public property sale:

**SECTION 2:** The Village of Johnsburg received the following bids for the purchase of said property:

Tom Schwartz - Johnsburg School District #12	\$15,500
Kevin Hiller - Pavement Solutions, LLC	\$10,500
Kyle Rechel - Rechel Septic Inc.	\$12,500
Joe Greenhill - Upland Construction & Maintenance LLC.	\$14,000

**SECTION 3:** The Board of Trustees for the Village of Johnsburg has accepted the bid from Tom Schwartz on behalf of Johnsburg School District in the amount of \$15,500

**SECTION 4:** The Village Administrator is hereby authorized and directed to sell to the Johnsburg School District for \$15,500 the herein named item now owned by the Village of Johnsburg.

**SECTION 5:** Upon payment in full, the Village Administrator is hereby authorized and directed to convey and/or transfer the aforesaid property to the respective buyer.

**SECTION 6:** This ordinance shall be in full force and effect from and after its passage by the corporate authorities.


