ORDINANCE NO. 2023-24-12

An Ordinance Amending Chapter 3, Village Administration, by adding Section 3.07, Non-Public Forums, of the Johnsburg Municipal Code

BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: The Village of Johnsburg Municipal Code shall be amended to add a new Section 3.07, *Non-Public Forums*, to Chapter 3, *Village Administration*, of the Village of Johnsburg Municipal Code as follows:

3.07 NON-PUBLIC FORUMS

- A. The offices of the Village staff, Village officials and the employees of the Village police department, the police booking area, holding cells, conference rooms and bathrooms in the David D. Domingez Municipal Center are not public forums. Such areas shall be marked as “non-public forum”. No member of the public shall access such area of the David G. Domingez Municipal Center marked as “non-public forum” unless expressly invited to do so by a member of the Village staff, a Village official or employee of the Village’s Police Department.
- B. PENALTY. Unless otherwise provided, any person, firm, or corporation violating 3.07 shall be fined not less than \$500.00 nor more than \$750.00 for each offense.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect ten days after its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
