ORDINANCE NO. 23-24-34

An Ordinance Amending Chapter 8 Parks and Playgrounds of the Johnsburg Municipal Code

BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: That Chapter 8.02 Operating Policy be amending adding Section C. Alcohol Prohibited as follows:

C. Alcohol Prohibited. The possession and/or consumption of alcohol in Village Parks is prohibited except as set forth in Section 8.03 F Use of Park Areas, and in the case of Special Events for which a Special Event Liquor License has been secured through the Village.

SECTION 2: That Chapter 8.03 Use of Parks, C. Fires, be amended as follows:

C. Fires. No person shall build a fire in any place other than a fireplace, fire pit, or a grill as constructed or affixed to the property by the Village or in a portable grill constructed of a suitable fireproof substance, or other area designated by the Village. Use of fire pits must be authorized in advance by the Village. No person shall drop, throw, or otherwise scatter lighted matches or other flammable materials within any park area or on any highway, road or street abutting or contiguous thereto. No person shall leave a picnic area before the fire is completely extinguished and before all trash in the nature of boxes, papers, cans, bottles, garbage and other refuse is placed in the disposal receptacles where provided. If no such trash receptacles are available, then refuse and trash shall be carried away from the park area by the picnicker to be properly disposed of elsewhere.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.


