**Ordinance No. 13-14-20**  
**An Ordinance Authorizing the Sale of Public Property**  
**Owned by the Village of Johnsburg**

**WHEREAS**, the **Village of Johnsburg**, McHenry County, Illinois, is in the opinion of a simple majority of the corporate authorities of the Village of Johnsburg, McHenry County, Illinois, and as provided in 65 ILCS 5/11-76-4 and:

**WHEREAS**, in the opinion of the corporate authorities of the **Village of Johnsburg**, it is no longer necessary or useful to or for the best interests of the **Village of Johnsburg** to retain ownership of the public property hereinafter described; and

**WHEREAS**, it has been determined by the Village President and Board of Trustees of the **Village of Johnsburg** to sell said public property for cash.

**NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF JOHNSBURG**, as follows:

**SECTION 1:** The Village President and Board of Trustees of the **Village of Johnsburg** find that the following described public property now owned by said jurisdiction is no longer necessary to said jurisdiction and said jurisdiction would be best served by the said public property sale:

**2007 Chevrolet Impala; VIN 2G1WS55R879413317**  
**PREVIOUSLY USED AS POLICE PATROL VEHICLE AND**  
**PUBLIC WORKS VEHICLE – 136k miles**

**2005 Ford Crown Victoria; VIN 2FAFP71W35X179814**  
**PREVIOUSLY USED AS A POLICE PATROL VEHICLE AND**  
**PUBLIC WORKS VEHICLE – 161k miles**

**SECTION 2:** The Village Administrator is hereby authorized and directed to sell through a public viewing and sealed bid process, the herein named items now owned by the Village of Johnsburg.

**SECTION 3:** Upon payment in full, the Village Administrator is hereby authorized and directed to convey and/or transfer the aforesaid property to the respective buyer submitting the highest bid for each vehicle.

**SECTION 4:** This ordinance shall be in full force and effect from and after its passage by the corporate authorities.


