ORDINANCE 13-14-14

An Ordinance Amending Chapter 8, Parks and Playgrounds, of the Johnsburg Municipal Code Adding Regulations regarding the Use of Tobacco Products on Park Property

SECTION 1: That Chapter 8 is amended as follows:

8.08 USE OF TOBACCO PRODUCTS

A. Use of Tobacco Products prohibited

The use of any tobacco product is prohibited within all buildings, facilities and vehicles owned, leased, or otherwise in the possession or under the control of the Village of Johnsburg, or within 15 feet of facility entrances/exits, windows that open and ventilation intakes. The use of any tobacco product is also prohibited on or within twenty-five (25) feet of any Village of Johnsburg playground, sports field, shelter or structure

B. Definition

Tobacco is defined to include any lighted or unlighted cigarette (clove, bidis, kreteks), ecigarettes, cigars, cigarillos, pipes, hookah products; and any other smoking product; and any smokeless, spit or spit less, dissolvable, or inhaled tobacco products, including but not limited to dip, chew, snuff or snus, in any form (orbs, sticks, strips, pellet, etc.); and all nicotine delivery devices that are not FDA-approved as cessation products.

C. Penalties for Violation

A person who violates any provision of this Ordinance shall be given a warning for the first offense within any 12-month period. A person who violates this Ordinance on two or more occasions within any 12-month period shall be fined as follows: 2nd offense: Fifty Dollars (\$50.00); 3rd or subsequent offense within any 12-month period One Hundred Dollars (\$100.00). The maximum fine for any single violation of this Ordinance shall be One Hundred Dollars (\$100.00). In addition to a fine, any person holding a Park Permit issued by the Village shall be subject to revocation of said Permit.

D. Enforcement

The Police of the Village of Johnsburg, Illinois, shall be and hereby are authorized and empowered to enforce this and all ordinances. This Ordinance shall not be construed to create any duty of the Village, its officers, or employees.

8.09 SETTLEMENT OF OFFENSES. Any offense arising under this Chapter 8, for which a specific penalty is not stated may be settled and compromised by the offender by payment to the Village the sum of money stated for a Class A violation in Chapter 1.07-E.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
