ORDINANCE 13-14-41

**AN ORDINANCE AMENDING CHAPTER 14, ANIMAL CONTROL OF THE
JOHNSBURG MUNICIPAL CODE AND SECTION 10, RESIDENTIAL DISTRICTS OF
THE JOHNSBURG ZONING ORDINANCE**

SECTION 1: That Chapter 14 is amended to add 14.03 as follows:

14.04 THE KEEPING OF CHICKENS – It shall be unlawful to keep chickens or other farm animals on property utilized in a residential manner. (Also see Section 10.6, Residential Districts, of the Johnsburg Zoning Ordinance).

SECTION 2: That Section 10, Residential Districts, of the Johnsburg Zoning Ordinance is amended to add 10.6 as follows:

10.6 – THE KEEPING OF CHICKENS – The keeping of chickens and/or other farm animals is not permitted in a Residential or Estate zoning district except in the case of Section 10.3-6 regarding the keeping of horses in the E-3 and E-5 zoning districts.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.


