# An Ordinance Amending Chapter 1.07E General Provisions of the Johnsburg Municipal Code

SECTION 1: That Chapter 1.07E regarding Offense Classes is amended as follows:

Class A - \$ 50.00

Class B - \$ 175.00

Class C - \$200.00

Class D - \$400.00

Class E - \$750.00

Class F - \$750.00

Class G - \$750.00

Class H - \$750.00

SECTION 2: That Chapter 1.07I is amended as follows:

I. The Village shall refrain from prosecuting any alleged offender for any offense for which the offender has successfully paid a settlement to the Village subject to section 1.07I

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
