**AN ORDINANCE AMENDING CHAPTER 12
NUISANCES OF THE
JOHNSBURG MUNICIPAL CODE REGARDING PENALTIES**

SECTION 1: That Chapter 12.05.01 is amended as follows:

12.05.01 INOPERABLE VEHICLES. (C)(1) Penalties

C. Penalties

1. Failure to comply with any of the provisions and requirements of 12.05.01 shall constitute a violation, and any person convicted of the ordinance shall be guilty of a Class C violation. Each day the violation continues shall be considered a separate offense. Proceedings may be commenced by notice to appear, summons, warrant or arrest.

SECTION 2: That Chapter 12.06 is amended as follows:

**12.06 PARKING MOBILE HOME MOTORHOMES, TRAILERS, and BOATS. (C)
Penalties:**

Penalties: Class C

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.


