AN ORDINANCE AMENDING CHAPTER 6 STREETS OF THE JOHNSBURG MUNICIPAL CODE

SECTION 1: That Chapter 6.17 is amended as follows:

<u>6.17 SETTLEMENT OF OFFENSES</u>. Any offense arising under this Chapter 6, for which a specific penalty is not stated may be settled and compromised by the offender by payment to the Village the sum of money stated for a Class C violation in Chapter 1.07-E.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
