***An Ordinance Amending Chapter 8.02 of the Johnsburg Municipal Code entitled
Operating Policy***

SECTION 1: That Chapter 8.02(A) is amended as to add:

3. The Rescue Squad Park Ice Skating Rink (adjacent to the Johnsburg Community Club grounds) shall be open daily from 7:30 am until 10:00 pm.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
