ORDINANCE NO. 14-15-4 An Ordinance Amending Certain Sections of Chapter 15, Traffic, of the Johnsburg Municipal Code

WHEREAS, the Village of Johnsburg, an Illinois municipal corporation (the "Village"), as the "local authority" relative to a certain public right of way in the corporate limits of the Village, hereby determines that such right of way, as set forth below, should have certain weight or other traffic restrictions placed on same;

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Johnsburg, McHenry County, Illinois, as follows:

SECTION 1: That the following text is hereby added at the end of Chapter 15 of the Johnsburg Municipal Code as subsection 15.16:

15.16. No through truck traffic on Church Street, Ivy Lane and Reed Avenue. Through trucks are prohibited on Church Street, Ivy Lane and Reed Avenue except as set forth in Section 15.11 (D). Any person, firm or corporation violating this prohibition shall be fined \$500.00 per occurrence.

SECTION 2: That Section 15.11, Weight Limits on Streets, of Chapter 15, Traffic, of the Johnsburg Municipal Code, shall be amended to add the following text:

15.11 Weight Limits on Streets

H. Maximum Per Vehicle – Church Street, Broadway Avenue, Fairview Avenue, Ivy Lane and Reed Avenue. It shall be unlawful to operate any vehicle (including any tractor, trailer and accompanying load) on Church Street, Broadway Avenue, Fairview Avenue, Ivy Lane and Reed Avenue within the Village when the weight of such vehicle exceeds six tons or when any such vehicle is registered as being in excess of six tons.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
