**ORDINANCE NO. 13-14-53**

***An Ordinance Authorizing the Sale of an Item  
of Personal Property Owned by the Village of Johnsburg***

WHEREAS, in the opinion of a simple majority of the corporate authorities of the Village of Johnsburg, McHenry County, Illinois, it is no longer necessary or useful to or for the best interest of the Village of Johnsburg to retain the following described personal property:

2005 Ford Crown Victoria VIN # 2FAFP71W35X1798114

now owned by it; and

WHEREAS, Tom Swartz has offered to purchase the 2007 Chevy Impala for the sum of \$450.00; and Richard J. Nugent - Lakeland Service Center has offered to purchase the 2005 Ford Crown Victoria for the sum of \$800.00

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF JOHNSBURG, McHenry County, Illinois, as follows:

SECTION 1: Pursuant to 65 ILCS 5/11-76-4, the President and Board of Trustees find that the following described personal property:

now owned by the Village of Johnsburg is no longer necessary or useful to the Village of Johnsburg and the best interests of the Village of Johnsburg will be served by its sale.

SECTION 2: Pursuant to said 65 ILCS 5/11-76-4, Edwin P. Hettermann be, and is hereby, authorized and directed to sell the following described personal property:

As follows:

SECTION 3: This Ordinance shall be in full force and effect upon its passage, by at least three-fourths of all the corporate authorities, approval in the manner provided by law and publication in pamphlet form (which publication is hereby authorized) as provided by law. If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.


