**AN ORDINANCE AMENDING CHAPTER 7 LICENSES AND PERMITS
OF THE JOHNSBURG MUNICIPAL CODE**

SECTION 1: That Chapter 7.01B is amended regarding fees as follows:

- B. Registration, Fee: All businesses with buildings, premises or operating from a residence in the Village shall register with the Village Clerk no later than April 30th of each year. Registration questionnaires shall be made available by the Village. An annual registration fee of \$50.00 shall be waived if the registration questionnaire is completed and returned to the Village Clerk by April 30th.

SECTION 2: That Chapter 7.07 is amended as follows:

7.07 SETTLEMENT OF OFFENSE. Any offense arising under this Chapter 7, for which a specific penalty is not stated may be settled and compromised by the offender by payment to the Village the sum of money stated for a Class C violation in Chapter 1.07-E.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.


