ORDINANCE 14-15-02

An Ordinance Amending Chapter 17.09A, Receptacles Required of the Johnsburg Municipal Code

SECTION 1: That Chapter 17.09 A is amended as follows:

17.09 DISPOSAL BY RESIDENTS AND/OR COMMERCIAL PROPERTIES

A. Receptacles Required. It shall be the duty of every owner, or his agent, or the occupant of any house, dwelling or other building in the Village wherein people reside or lodge, or where animal or vegetable food is prepared or served, and at all times, to maintain in good order and repair a separate receptacle to be used for the purpose of depositing garbage and other similar refuse. For residential properties, such receptacle(s) shall be watertight, made or constructed of metal or plastic, and shall be equipped with a close fitting cover, and shall be of a capacity of not less than five (5) nor more than thirty-five (35) gallons. Additionally, residents may rent containers as provided for in the Village's Residential Solid Waste, Recycling and Landscape Waste Removal Contract. At no time shall commercial containers be permitted for regular weekly pickup of garbage at single family detached dwellings or townhome units.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
