**An Ordinance Amending Chapter 6 Streets, of the  
of the Johnsburg Municipal Code Prohibiting the use of Snowmobiles  
other Motorized Vehicles on Sidewalks within the Village of Johnsburg**

SECTION 1: That Chapter 6.13 D is added as follows:

**D. Prohibited Use of Sidewalks** -- Snowmobiles and other motorized vehicles are not permitted on sidewalks within the Village. A violation of this section shall be considered a Class D offense.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
