

**ORDINANCE 15-16-01**  
**An Ordinance Amending Chapter 24, Building Code**  
**of the Johnsburg Municipal Code**

SECTION 1: That Chapter 24.01 Adoption of Building Codes be amended to read as follows:

**24.01 ADOPTION OF BUILDING CODE.**

The following list of codes is hereby adopted as part of the Building Code of the Village of Johnsburg, McHenry County, Illinois, for the control of buildings and structures as therein provided in each code. Each and all of the regulations, provisions, penalties, conditions and terms contained in each code described below are hereby referred to, adopted and made a part hereof as if fully set forth in this Ordinance:

- A. 2006 International Building Code;
- B. ~~2006~~2012 International Energy Conservation Code;
- C. 2006 International Fuel Gas Code;
- D. 2006 International Mechanical Code;
- E. 2006 International Property Maintenance Code;
- F. 2006 International Residential Code;
- G. 2006 Wildlife-Urban Interface Code;
- H. 2005 National Electric Code;
- I. 2004 State of Illinois Plumbing Code
- J. 2006 International Fire Code

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
