ORDINANCE 15-16-31

An Ordinance Amending Section 11, Business District and Section 16, Conditional Uses of the Johnsburg Zoning Ordinance.

SECTION 1: That the Business District Use Chart in Section 11 and the Conditional Use Chart in Chapter 16 is amended to include Outdoor Shooting Ranges as conditional uses in the B-4, I-1 and I-2 Zoning Districts:

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
