**AN ORDINANCE AMENDING CHAPTER 14, ANIMAL CONTROL
OF THE JOHNSBURG MUNICIPAL CODE**

SECTION 1: That Chapter 14.04 is amended as follows:

14.04 THE KEEPING OF CHICKENS – It shall be unlawful to keep chickens or other farm animals on property utilized in a residential manner. Any offense arising under this Chapter 14.04 shall be a Class A violation.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
