## **ORDINANCE NO. 16-17-06**

An Ordinance Granting a Variance to Section 7.1-2 Accessory Buildings and Structures for the property Commonly Known as 2201 Fairview Avenue, Johnsburg, Illinois

WHEREAS, Barbara Franz filed with the Village Clerk of the Village of Johnsburg, McHenry County, Illinois, a request for a Variance to 7.1 Accessory Buildings and Structures more specifically 7.1-2 to permit the placement of an accessory structure on a parcel prior to the establishment or construction of the main building to which it is an accessory; and to 7.1-7 to allow for the construction of a domestic storage shelter not exceed 400 square feet in size and 12 feet in height in lieu of the otherwise permitted 168 square feet in size and 10 feet in height. The variance is to permit the construction of a storage shelter for personal, residential use for the property commonly known as 2201 Fairview Avenue, Johnsburg, Illinois 60051;

WHEREAS, A PUBLIC HEARING was held by the Planning & Zoning Commission, after due notice in the manner provided by law; and

WHEREAS, THE PLANNING & ZONING COMMISSION, has, upon holding a hearing, made a report of said request to the Village Board; and

WHEREAS, THE VILLAGE BOARD has reviewed the minutes put forth by the Planning & Zoning Commission and based upon the Commission's findings that the granting of the variance is in harmony with the general purpose and intent of the Zoning Code and that the zoning request is consistent with the primary use and zoning of the area.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF JOHNSBURG, McHenry County, Illinois, as follows:

SECTION 1: That a variance is granted to 7.1-2 to permit the placement of an accessory structure for personal, residential use on a parcel prior to the establishment or construction of the main building to which it is an accessory; and to 7.1-7 to allow for the construction of a domestic storage shelter not exceed 400 square feet in size and 12 feet in height in lieu of the otherwise permitted 168 square feet in size and 10 feet in height for the property commonly known as 2201 Fairview Avenue, Johnsburg, Illinois 60051.

SECTION 2: That all requirements set forth in the Zoning Ordinance of the Village of Johnsburg, as would be required by any owner of property zoned in the same manner as the Subject Property, shall be complied with, except as otherwise provided in this Ordinance.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid,

such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
