

ORDINANCE NO. 16-17-16

***An Ordinance Authorizing the Sale of an Item
of Personal Property Owned by the Village of Johnsburg***

WHEREAS, in the opinion of a simple majority of the corporate authorities of the Village of Johnsburg, McHenry County, Illinois, it is no longer necessary or useful to or for the best interest of the Village of Johnsburg to retain the following described personal property:

1994 Massey 50XE Loader Tractor Serial # 5167G1800

now owned by it; and

WHEREAS, Johnsburg School District #12 has offered to purchase the 1994 Massey 50XE Loader Tractor Serial # 5167G1800 for the sum of \$5,100.00;

WHEREAS, bids were also received from Lakeland Service Center for \$3000.00, Hiller Property Management, LLC for \$3,500.00 and Reinwall Marine Service, Inc. for \$3,100.00;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF JOHNSBURG, McHenry County, Illinois, as follows:

SECTION 1: Pursuant to 65 ILCS 5/11-76-4, the President and Board of Trustees find that the following described personal property:

1994 Massey 50XE Loader Tractor Serial # 5167G1800

now owned by the Village of Johnsburg is no longer necessary or useful to the Village of Johnsburg and the best interests of the Village of Johnsburg will be served by its sale.

SECTION 2: Pursuant to said 65 ILCS 5/11-76-4, the Village Administrator be, and is hereby, authorized and directed to sell the following described personal property:

1994 Massey 50XE Loader Tractor Serial # 5167G1800 to Johnsburg School District #12 for the sum of \$5,100.00;

SECTION 3: This Ordinance shall be in full force and effect upon its passage, by at least three-fourths of all the corporate authorities, approval in the manner provided by law and publication in pamphlet form (which publication is hereby authorized) as provided by law. If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.
