## ORDINANCE NO. 16-17-29

An Ordinance Abating Taxes Levied to Pay Principal and Interest on Certain Waterworks and Sewerage Revenue Bonds and Alternate Revenue Source Bonds (in Lieu of Such Revenue Bonds), Series 2006 in the Village of Johnsburg

WHEREAS, the President and Board of Trustees (the "Board") of the Village of Johnsburg, McHenry County, Illinois (the "Issuer"), by Ordinance 1997-98-14 passed on the 15th day of July, 1997, did provide for the issuance of \$15,000,000 waterworks and sewerage revenue bonds (utility tax, sales tax, revenue sharing receipts pledge) and alternate revenue source bonds with separate notices of intent: i) to issue waterworks and sewerage revenue bonds and ii) to issue waterworks and sewerage revenue alternate bonds (being a general obligation in lieu of revenue bonds); and

WHEREAS, the Board, by Ordinance 05-06-34 passed on the 17th day of January, 2006 (the "Ordinance") did provide for the issuance of up to \$775,000 general obligation waterworks and sewerage refunding bonds (alternate revenue source), series 2006 (the "Bonds"), and the levy of a direct annual tax sufficient to pay principal and interest on the Bonds; and

WHEREAS, the Issuer will have Pledged Revenues (as defined in the Ordinance) available for the purpose of paying the debt service due on the Bonds during the next succeeding bond year; and

WHEREAS, it is necessary and in the best interest of the Issuer that the tax heretofore levied for the year 2013 to pay such debt service on the Bonds be abated.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF JOHNSBURG, McHenry County, Illinois, as follows:

SECTION 1: The Pledged Taxes heretofore levied in the Ordinance for 2016 shall be abated as follows:

Year Amount Levied Amount to be Abated Remainder of Tax to be Extended

SECTION 2: Except for the levy to pay the principal and interest on the bonds as described above, no other levy imposed by the Board is to be affected by this ordinance.

SECTION 3: Upon the passage of this ordinance, the Clerk shall file a certified copy of this ordinance with the McHenry County Clerk, and it shall be the duty of the McHenry County Clerk to abate said tax levied for the year 2016 in accordance with the provisions hereof.

SECTION 4: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 5: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 6: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
