In summary he stated the public knowledge on these vehicles is unknown and the sounds emanating from the vehicles give the perception they are traveling faster than they truly are and the public then makes assumptions. He offered his services to further educate and elaborate if the committee wishes given his profession with UTVs.	
	J. Barret (3310 Chellington Dr) – Addressed the committee regarding violations and complaints noted via in-person and/or social media. In summary he stated UTVs are operating in areas they are not permitted to be in use and are the violators for the communities Non-Highway vehicle ordinance use. He also advised that a village official encouraged the posting on social media of operators in violation. He expressed that the enforcement on said activities should be handled by the police department. He expressed that the main issue is that operators are operating were they should not be.	
	J. Buff (1113 Florence St (Non-resident, community supporter)) – Addressed the committee regarding observations of violations in town; however, noted no actual official complaint to his knowledge were reported on. He stated in summary he is a supporter of Non-Highway vehicle use in the Village and enforcement is the issue that needs to addressed. Casey Lane (3302 Chellington Dr) – Addressed the committee regarding his opinion that no matter what modification are made to ordinance there always someone that would not follow said regulations. There is a small portion of population that will not comply and expressed how much he enjoys the use of Non-Highway vehicle and supporter that the Village allowed said permitted use.
