**MINUTES** - Trustee Frost moved to approve the minutes. Trustee Curry seconded the motion. Trustee McEvoy clarified that at the last meeting, he was not objecting to the legalization of marijuana but was emphasizing that the Board needs to establish some regulations regarding the matter. He explained that he is concerned that the minutes do not accurately reflect his position. Ms. Peters stated that she would provide clarification in the minutes. All Trustees voted aye on the roll. Motion carried.

**PRESIDENT'S REPORT** – President Hettermann reminded all of the upcoming Saufen und Spiel Parade and added that on September 15<sup>th</sup> at 1:00 p.m. the Village will hold a dedication ceremony for Lenart Park and asked all to attend.

19-20-13 AMENDING SECTION 9 SIGNS – Trustee Foreman questioned if the two-second interval established for electronic signs is sufficient. Village Administrator Peters explained that the reference regarding interval timing is included in the ordinance to define a minimum acceptable timing. Any changes in displays lasting less than two seconds is considered flashing or strobing and is not permitted. The Board asked that the two Village Community Events Signs be set for two-second intervals between each slide so that the board can observe the impact. Frank Urbina suggested that the Board may want to reduce window signage for uses other than grocery stores to 25% of the window. The Board discussed the impact for other uses such as liquor establishments. Ms. Peters stated that she would obtain additional input prior to the next meeting.

**ADJOURNMENT** – Trustee Foreman moved to adjourn the meeting. Trustee Klemstein seconded the motion. All Trustees voted aye on the roll. Motion carried at 7.22 p.m.
