PRESIDENT'S REPORT – President Hettermann recommended the appointment of Kristi LaMontagna to the Community Affairs Events Committee and Aubrey Wuchter to the Community Affairs Parks and Facilities Committee. The Board concurred with the appointments.

NEW BUSINESS - The Board performed a first review of Ordinance 19-20-44 Amending Chapter 9 to include language regarding BYOB Liquor Licenses. Trustee Curry questioned if the Village received a request for the amendment. President Hettermann confirmed that a new restaurant owner planned in the Shops at Fox River Center requested the Board's consideration of a BYOB license. Trustee Frost stated that the Ordinance Committee reviewed the proposed amendment and recommended approval but had some concerns about persons possibly misusing Special Event licensing to get around having a BYOB license. Ms. Sofiakis reported that the Special Event License is used in when an entity, who does not

otherwise have a liquor license, wishes to sell alcohol at a special event. The BYOB license does not permit the sale of alcohol by the license holder. Trustee Klemstein reported that the Finance Committee also reviewed the proposed amendment and recommends approval. The matter will be included on the next agenda for Board consideration.
