AUDIENCE PARTICIPATION – John Murphy from Johnsburg School District was in attendance with several students participating in a program called Engaging Youth for Positive Change. Students Nash Miller, Noah Miller, Paige Hansen and Austin Koontz approached the Board regarding establishing more smoke free public places. They discussed a survey that was done the results of which indicated that 60% of the participants felt more should be done to prevent smoking in public places. Suggestions included more enforcement and increased fines. Additionally, creating a better separation of smoking and non-smoking outdoor areas in restaurants was suggested. Trustee Huemann urged the students to get feedback from the business owners regarding the matter too. President Hettermann thanked the students for sharing the information and requested a copy of the survey results.

PRESIDENT'S REPORT – Village Administrator Claudett Peters reported that the Village's Church Street Project was moved up to the Approved Funding list through the Council of Mayors and has been approved to receive \$1,500,000 in STP funding. She explained that Phase I Engineering is underway and Phase II will begin later in the year. The project is planned for a bid letting in November of 2016 with construction expected to begin in the Fall of 2017.

NPDES - Village Engineer Tim Hartnett conducted an informational session regarding the Village's National Pollution Discharge Elimination System Program related to storm water runoff. He discussed the requirements of the program and what the Village has instituted to meet the requirements. He informed the Board that the Village passed the NPDES Phase II audit last year with no issues.

Trustee Huemann informed the Board that JABA was having a cookout at Sunnyside Park on Thursday, June 4th from 5-7 p.m. and encouraged them to attend.

Trustee Hutchinson informed the Board that the proposed budget will be handed out at the June 16th meeting with a presentation and action on the budget to take place at the following meeting. Trustees agreed to check their calendars to determine if that meeting should take place on June 25th or July 7th in light of the 4th of July holiday.

ADJOURNMENT – Trustee Hutchinson moved to adjourn the meeting. Trustee Frost seconded the motion. All Trustees present voted aye. Motion carried at 7:52 p.m.
