GOLF COURSE ELECTRICAL IMPROVEMENTS - At the December 18, 2018 meeting, the Board approved a payment to Carey Electric in the amount of \$5,300 and to Maple Construction in the amount of \$19,900 for gas and electrical improvements at Chapel Hill Golf Course

VILLAGE LIABILITY INSURANCE - At the December 18, 2018 meeting, the Board approved a proposal from Arthur J. Gallagher Risk Management Services, Inc in the amount of \$100,010 for the Village's Property Casualty, General Liability and Worker's Compensation insurance.
